**SECTION 1 PROGRAM INFORMATION – Read and Retain for Your Records**

**REMISSION OF FEES FOR A FORMER MORTON MEMORIAL HIGH SCHOOL STUDENT (APPLICATION #1)**

The Indiana General Assembly established defined educational benefits for those living at the Indiana Soldier's and Sailor's Home for Children (ISSCH) and/or admitted to Morton Memorial High School because a family member served in the U.S. Armed Forces. The benefit covers up to 124 credit hours of tuition and regularly assessed fees (fees charged to all students) as defined by the Commission for Higher Education and the State Student Assistance Commission of Indiana (SSACI), to attend a state-supported institution. The benefit is paid by SSACI to schools upon receipt of bill. The 124 hours of aid benefit provided by this program represents any and all grant aid paid by the state of Indiana no matter the source but is separate and distinct from any other tuition-specific aid the student may receive.

To be eligible, applicants must maintain Satisfactory Academic Progress (SAP) as determined by the college; not be in default or overpayment of a student loan or grant; annually **file the appropriate (and error-free) academic year's Free Application for Federal Student Aid (FAFSA)** - for example, file a 2011-2012 FAFSA for the 2011-2012 academic year, a 2012-2013 FAFSA for the 2012-13 academic year, etc.

Courses must be for college credit. Only the institutions listed on this application are eligible to participate for you to receive this benefit. Eligibility is not limited by age of the applicant and can be used as an undergraduate or graduate student; **however tuition and regularly assessed fees for graduate students will be paid at the undergraduate rates charged by the school.**

**REMISSION OF BOOKS FOR A FORMER MORTON MEMORIAL HIGH SCHOOL STUDENT (APPLICATION #2)**

Students qualifying for the Remission of Fees for a former Morton Memorial High School Student benefit can receive remission of costs for course-related books. Students can continue to receive remission of cost for books even after exhausting the 124 credit hours of tuition and regularly assessed fees provided under the Remission of Fees for a Former Morton Memorial High School Student benefit.

**HOW TO APPLY FOR BENEFITS**

1. Annually file a current year Free Application for Federal Student Aid (FAFSA). The preferred FAFSA filing date for the 2011-12 academic year is March 10 (date received) prior to the academic year the student plans to attend college. However, the latest that a student can file a FAFSA is thirty (30) days prior to the end of the semester.
2. Mail the completed Applications for Remission of Fees/Books for a Former Student and/or Graduate of Indiana Soldiers and Sailors Children's Home / Morton Memorial High School (Knightstown) to:

The state may not remit tuition (Application #1) or books (Application #2) for terms completed prior to the filing of an error-free FAFSA and the application for the benefit. The veteran's period of service, relationship to the student, and student attendance at the ISSCH will be verified and the applications returned to the student. Present the verified applications to the Financial Aid Office at the appropriate college. The student and/or veteran (if living) must provide any information the state or school determines could be relevant to the student's eligibility for benefits. Questions on eligibility should be directed to the Indiana Department of Veterans Affairs at 317/232-3910 or 800/400-4520. All questions about fee remission payments, including a historical account of hours used under the program, should be directed to SSACI at 317/232-2350.

**To help ensure your school has time to bill SSACI for your remission of fees by each semester's deadline, it is recommended that approved applications be submitted to the financial aid office at your school no later than thirty (30) days prior to the end of the semester.**

**SECTION 2****FILING INSTRUCTIONS****REMISSION OF FEES/BOOKS FOR A FORMER MORTON MEMORIAL HIGH SCHOOL STUDENT**

*Note: All applicants must file the appropriate year's Free Application for Federal Student Aid (FAFSA), preferably by the state of Indiana's **March 10 (date received)** filing deadline, but no later than thirty (30) days prior to the end of the semester. Applicants can file the FAFSA online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). By filing the FAFSA, applicants are applying for other financial aid that could be awarded in conjunction with fee/book remission benefits.*

- A. Applications #1 and #2 must be completed in **INK**, else they will be returned without verification.
- B. Student Data:**
1. Fill out all lines completely and **PRINT CLEARLY!** Applications will be returned unapproved if any question is left unanswered.
  2. List the college you will attend. **You should be accepted by school prior to application.** Your applications will be mailed to the address provided.
- C. IDVA Verification: Do not write in this area; verification is completed by the Indiana Department of Veterans Affairs (IDVA).
- D. After application #1 is approved by IDVA, submit both applications to your college's financial aid office for processing.
